## **“Are the Media Serving Our Democracy... or Themselves?” “Lunch with League“, Thursday, March 19**

The days of Edward R. Morrow and Walter Cronkite are gone. The quality of the media we had growing up is no longer there. The United States is ranked 36th in the world in terms of press freedom, tied with Bosnia and Herzegovina, South Africa, Spain, and Taiwan. Tied for first are Iceland, Luxembourg, and Norway.

### **How have our media sunk to such lows?**

These questions and more will be addressed at our luncheon on March 19.

Increasingly, the media's failure to provide diverse viewpoints and unbiased information is undermining the strength of our democracy. Dissatisfaction with news coverage of events ranging from the 2000 presidential election to the war in Iraq has given media issues a new sense of urgency. The more corporate conglomerates buy up independent news outlets, the fewer voices and perspectives the public hears, and the less accountable broadcasters are to the public.

The media no longer are required to meet their obligations to serve the public by promoting diversity, accessibility, and accountability among corporations and the government agencies that regulate them. Over the years, the FCC has lessened the requirements needed for corporations to use the public airwaves for free. We now find that we have media which care more about ratings than informing the public, more about profits than depth.

Before we can work on solutions, we need to understand the problems:

### **Problem 1: Media Consolidation**

The 1996 Telecommunications Act allowed big media conglomerates to dominate markets all over the U.S. Rather than hundreds of voices and opinions writing and editing our news, three corporations are now in charge of much of the information we receive. More of us are aware that the rest of the world is getting news that we are not.

The structure of San Diego City government should promote responsive, responsible and efficient government with adequate checks and balances of power, with equal opportunities for citizens and with provisions for citizen participation.

### **The suggested change is:**

LWVSD supports *a city government with* structures and procedures *that* promote responsive, responsible and efficient government with adequate checks and balances of power, with equal opportunities for citizens and with provisions for citizen participation.

Please plan to attend a unit meeting and join in on the discussions and consensus.

**Letter from Co-President Anne Hoiberg**

As the League begins its 90<sup>th</sup> year, we can be proud of our 89 years of fostering good governance and promoting the civil and human rights of all peoples. While our accomplishments are noteworthy, it seems as though progress in achieving equal human and civil rights for U.S. women is pitted with starts, stalls, and stops, followed by more starts and stalls.

**League's policy of equal rights and equal opportunity:**

The League's work in promoting pay equity stems from concern over the feminization of poverty. The struggle for equal pay was illustrated in early photographs as women in 1911 marched through the Washington, D.C. streets demanding equal pay for equal work. Almost one hundred years later, January 2009, the U.S. Congress adopted the Ledbetter Fair Pay Restoration Act, righting a wrong experienced by thousands and thousands of women—being paid less than their male counterparts. Passage of the Paycheck Fairness Act in the U.S. House of Representatives occurred this January while the U.S. Senate dithered about this legislation at the expense of women's pocketbooks.

**League's Promotion of Representative Government:**

Our current U.S. Congress reflects an under-representation of women, younger people, and minorities, which is attributable in part to incumbency. Once elected, many representatives can count on living out their "golden years" serving in the U.S. Congress; for example, remaining in Congress for men in their seventies, eighties, or nineties seems to be the norm. The slow progress of women's election to Congress is shown by the November 2008 election results, which brought four more women to the U.S. House of Representatives of 435 members and one more to the 100-member U.S. Senate, both now at 17% women to 83% men.

**League's Policy on Reproductive Choices:**

Since the early 1980s and throughout the 1990s, the League worked to protect a woman's right to privacy; to overturn the "gag rule" that prohibited abortion information, services, or referrals by family planning programs funded under Title X; to support the International Family Planning Act; to oppose the military's policy of not funding a service woman's abortion; and to oppose legislation banning late-term abortions. In January and February 2009, the "gag" rule was lifted by President Obama's executive order and funding to the United Nations Population Fund was reinstated.

League's work on these social issues continues, an incredibly slow process of persistence and dedication to our human and civil rights; in my next commentary, League's work and the campaigns to end violence against women and children will be highlighted.

**“The Politics of Science”**

The LWVSD will moderate a panel consisting of Joseph Panetta, the CEO of Biocom; Scott LaFee, Science writer for the U-T; Council Member Sherri Lightner, (tentatively scheduled) Rep. Rush Holt (D. NJ) and PhD in Physics; Susan Hackwood, Executive Director of CA Council on Science and Technology.

We will be investigating the perception of science in the US today, the effect of government policies on the pursuit of science, and the ways government undermines the purity of scientific exploration and research.

American students rank in science far below their counterparts in other developed countries. Is that due to the quantity or quality of their science education or is it that the value of science is underestimated in today’s American culture? The panelists will be sharing their insights as to what we can do to bring the image of science away from the nerdy or bizarre to the modern, interesting and relevant posi-

tion that it needs to be in to draw more young people into the pursuit of science.

**Media- (Continued from page 1)****Problem 2:****The Media is failing to serve local community interests.**

In the last 15 years, we have lost more than half of all our investigative reporters. With fewer investigative reporters, less information gets to the public. Corporations pool news information so that a public interest story from one city is shared throughout the country. "The more disconnected the ownership of the media is from a community, the less it is devoted to serving it."

**Problem 3:  
Public Broadcasting**

Public Broadcasting has been the target of repeated assaults on its budget, including a 56 % cut in the 2009-10 budget. Yet it consistently ranks at the top of being the most trusted among institutions that include Congress, the courts, the federal government, commercial broadcast channels, newspapers and cable television

**Problem 4:****New Media's capacity to improve democracy is now under attack.**

The internet looks to be a place that can remedy a

lot of the difficulties that have been plaguing our access to information. Its promise is huge. But there are two things that can limit this promise. One, we need to have internet access for everyone. The other problem is that corporate interests are trying to take over this medium too. To protect us from the corporations making the choices of what parts of the internet we have access to, we need to work for Net Neutrality.

All in all, there is a lot for us to learn. Our two speakers for our March Luncheon will be here to help us.

Jon Bartholomew is the Associate Director for Common Cause and the source of much of the information for this article. He writes extensively on the subject.

## Inauguration Week in our America

President Barack Obama's Inaugural Speech inspired all of us to remember that we Americans can accomplish anything when we embrace a "common purpose," that we will succeed when we extend opportunity to all in achieving our "common good," and that we will play a role in ushering in peace when we realize our "common humanity." Equally important, he reminded world leaders that we Americans "will extend a hand if you are willing to unclench your fist."

Throughout the week, the tears couldn't be stopped, especially when our President urged us to "pick ourselves up, dust ourselves off, and begin again the work of remaking America." Yes, the work has begun.
