**Co-President's Report  
Outcome of Board Retreat**

Our League Board retreat was held on July 10th at Beryl Flom's beautiful home, and we had a highly productive and fun day. We examined issues including our League's nonpartisan policy, bylaws, LWVUS mission statement, "How and When to Take Action" in League, Co-Presidents' goals for the upcoming year, each Board member's ideas, goals, and plans for the upcoming year, and special projects that are being planned. We also elected Jeanne Brown as our League's First Vice President.

At the start of the retreat, we reviewed and discussed the significance of our League's nonpartisan policy. We reviewed how the LWVSD does not support or oppose any political party or any candidate. In addition, we discussed the importance of Board members using discretion in promoting or expressing personal political views so that people of varying viewpoints will feel comfortable at League gatherings. Of course, our League is political in the sense that we do take positions on various issues.

We were fortunate that Lottie Fox, our Management Training Advisor (MTA), attended our retreat. She made a very interesting and informative presentation titled, "How and When to Take Action", and she stressed that action follows education at all levels of League. Interest in an issue leads to study. Study leads to member education and study adoption (called a position). Positions at any level of League may be used as the basis for local action. Lottie also conveyed how our League might set priorities for working on issues and how we can determine the level of action for issues.

In addition, we talked about Anne and my Co-Presidential goals for the year that include:

- How can the League use various modes of communication (website, internet, op-ed pieces, letters to the editor, town hall meetings) more effectively?
- How can League become a stronger and more visible force in our community?
- How can we promote high quality League studies and participation by our members?
- How can we introduce and welcome more new ideas to our League?
- How can we increase fundraising?
- How can we retain and attract new members?

LWVSD has about 100 members through this National League system, but LWVUS has decided to drop the program. This means that we will need to work harder to recruit new members locally. ### Dues for New Members

We have decided to change the dues structure for new members. In the last several years, new members paid \$65/year. In the second year of membership, we have been prorating the membership dues so that most people renew on July 1. This requires numerous special letters which we are going to eliminate as we become more automated. People who join between July 1 and January 30 will now pay \$65 and people who join for the first time starting February 1 will pay \$50. Everyone will now renew on July 1. Additional household membership dues will remain the same at \$35/year.

## Public Policy Committee Report

Our League's first Public Policy Committee meeting of the 2010 – 2011 year was held on Friday, July 9, 2010. At this first organizational meeting, I distributed a seven-question survey to committee members asking for their input about the committee. Following are the survey questions and committee members' responses:

1. What is the mission/purpose of our Public Policy Committee in your view?
  - ◆ Act on LWVSD positions after knowing the background and issues; work with ILO on overlapping issues. (ILO is our inter-league organization)
  - ◆ Keep current on issues facing us locally, and act as a League to support or oppose.
  - ◆ Review and propose Positions for League consideration.
  - ◆ Focus on city issues.
  - ◆ Identify issues/concerns related to city governance and take a stand – and act on them; review League Positions.
  - ◆ Review and propose Positions for League consideration; consider also doing research on various policy issues of interest.
  
2. What public policy issues would you like the Committee to examine?

The group recognizes that we must be flexible with issues, since new issues continually arise. Some frequently suggested issues to examine are: Balboa Park, downtown waterfront, outsourcing/privatization, downtown Central Library, homelessness in San Diego, and San Dieguito Park. There are others that we will consider also.

3., 4., 5. All attendees are willing to work in small groups of two to three people to examine particular issues and then report back to the entire Public Policy Committee with their findings. All attendees would be interested in occasionally having guest speakers discuss various public policy topics at our meetings. All but one attendee would be interested in our committee members occasionally reading a policy-oriented book on a particular topic and then discussing it at our meetings.

6. What other suggestions do you have for the way our Public Policy Committee meetings should be structured?
  - ◆ Have open discussion.
  - ◆ Have groups give reports at monthly meetings.
  - ◆ Have interactive meetings with lots of input and feedback from Committee members.
  
7. How can our Public Policy Committee help League become a stronger and more visible force in our community?
  - ◆ Revitalize the Observer Corps.
  - ◆ Provide a monthly report of Committee activity in the *Voter* and on the League website.
  - ◆ Do publicity, letters, op-eds, etc. on work that also increases membership.
  - ◆ Get out there!
  - ◆ Present current issues to all of our members.

The Committee will incorporate much of this input. Please join us at our next Public Policy Committee meeting that will be held on Friday, August 13, 2010 at 9:30 a.m. in the League office.

## Central Library Update

The queue entering “Security” inched through the ground floor of City Hall on June 28, the day the City Council voted on the whether or not to begin construction of the Central Library by August 1. The gracious donors to the San Diego Public Library Foundation assembled near the speakers’ section while members of the nonprofit community and devoted library users clustered in the side rows. Former basketball star Bill Walton towered over everyone even when he was seated, and his comments about his librarian-storyteller mother brought tears to the eyes of even the staunchest anti-library penny-pincher. Joan and Irwin Jacobs received a huge round of applause for their donation of \$20 million, while appreciation also was expressed for the other generous contributors who brought the total of donations for the Central Library construction to almost \$31 million. Millions more are needed to complete the project, but assurances from Chair Judith Harris and Vice-Chair Mel Katz of the library foundation, sealed the deal, with Sherri Lightner and Carl DeMaio voting against this project.

The first efforts to establish a library in San Diego date back to 1897, according to Bob Kelly and Ben Haddad of the San Diego Foundation. With encouragement from The Wednesday Club, Lydia Horton urged Andrew Carnegie to support construction of a library in San Diego, the first library in California and one of the more than 2,500 libraries that Carnegie established.

Over the years, League has conducted studies of the library system in San Diego. Our 1989 two-

year study on Central Library Siting concluded that while the cost of a new building is a crucial consideration, a more important factor is building the Central Library large enough to encompass all present and projected functions for a minimum of 50 years. In addressing the criteria of architecture, public transportation, downtown parking, walking distance from home or business, and proximity to a residential area as well as cultural and civic center buildings, League selected Lane Field as the ideal site for the Central Library. The East Village location at 330 Park Boulevard was selected instead.



Our testimony at City Hall on June 28 supported the construction of the Central Library, using our position and

results of the 1989 study. In addition, I felt compelled to commend the Central Library on its many programs and exhibits. Recently, from June 14 – 16, the Central Library commemorated James Joyce’s *Ulysses* with a series of programs: A movie and lecture on the life of James Joyce and his influence on other writers, a lecture on *Ulysses* by a UCSD professor to celebrate Bloomsday (June 16) in the beautiful Wangerheim Room, and a three-day, noon-hour reading of Molly Bloom’s soliloquy performed by an superb actor from Mo’olelo Performing Arts Company. Now, that’s the type of programming one expects from a world-class library. With completion of the Central Library in 2013, San Diego will have a world-class library in which to continue offering world-class programs to San Diegans!

## MEET YOUR BOARD MEMBERS

### Susan E. Baer, Ph.D., Co-President

I was born and raised in Hanover, PA, a small town with lovely rolling green hills close to Gettysburg. I have one older brother who currently lives in Pennsylvania. Both of my parents passed away within the last six years.

My first taste of politics came in high school when I was elected to the Student Council, and I was also elected class Secretary. In high school, I also played tennis on the varsity team. Achieving high grades and learning new things have always been extremely important to me, and I earned the title of senior class salutatorian.

In college, I majored in Economics, and I came to love my newfound freedom there, although always remaining highly cognizant of my coursework and the big picture. I graduated Summa Cum Laude. After college, I yearned to leave my small town life for the city, and I moved to Baltimore, MD where I worked for several years as a bond analyst at Legg Mason, Inc., an investment banking firm.

However, the winter weather was quite severe there, even for a Pennsylvanian, and I longed for a warmer climate. Thus, I was ecstatic when I was offered a tenure-track position as an assistant professor of Public Administration at San Diego State University. I worked at San Diego State University for eight years where I earned tenure and was promoted to associate professor. I have published numerous public policy articles in peer-reviewed journals and books. Although I won several teaching and advising awards, I did not feel a passion for teaching, and I was restless to try something new. Thus, I resigned from my associate professor position last year in order to pursue other opportunities. I feel blessed that I am in a financial position to be able to do so.

Since then, I have served on a number of local nonprofit Boards including our League, and I have learned a great deal about the nonprofit world. What's next for me professionally? I am not sure. I realize that the arc of my life may not be perceived as the norm. I believe that life is a process, that this process itself has great value, and I welcome any future opportunities that might arise. Right now, I am focusing hard on learning all that I can about League (and I do have a lot to learn) in order to do my best as your Co-President. I am honored that you have elected me to share this position with the amazing Anne Hoiberg.

Last but definitely not least, I have been married to my loving, understanding, and very patient husband Bruce since 2003. Our German Shepherd dog, Max, and our Labrador Retriever, Bear, are our two "kids." We enjoy a number of activities including taking walks with the dogs, going to see plays and musicals every chance we can, and traveling. We are going on our first photo safari to Tanzania in September, and I can't wait!

She served as President of Zonta International – La Jolla, an organization committed to advancing the status of women worldwide and was honored as “Young Career Woman of the Year” by the Business and Professional Women Foundation.

Ms. Chavez earned a Bachelor of Science degree from Central Washington University in Public Health Administration and a Bachelor of Science degree in Accounting from the University of Phoenix. An avid sportswoman, Ms. Chavez enjoys golfing, fishing, and skiing (she was a member of the National Ski Patrol) and holds a private pilot's license. She is also a certified Religious Education Teacher.

Ms. Chavez and her husband Scott Harmes currently reside in Valley Center, California. They are the proud parents of two adult children.
